- **1. Call to Order** Mayor Gregory called the meeting to order at 6:51 and a quorum was present.
- **2. Invocation, Pledge of Allegiance, and Texas Pledge-** Invocation was given by Mayor Gregory. All in attendance cited the Pledge of Allegiance and Texas Pledge.
- 3. Citizens to be Heard There were no citizens to be heard.

5. Executive Session

A. B. Discuss and consider action on supporting "It's Time Texas Community Challenge" presented by HEB.

MOTION: Councilman Schott made a motion to support "It's Texas Community Challenge" presented by HEB, seconded by Councilwoman Watson. Motion passes 5-0.

A. Discuss and consider Ordinance No. 111016-01 approving purchasing policy.

MOTION: Councilwoman Moczygemba made the motion to approve Ordinance 111016-01 approving a purchasing policy, seconded by Councilwoman Watson. Motion passes 5-0.

8. Capital Improvement Update

- A. Water Line CEC provided information for potential completion date, which they are projecting the following week. Estimated 35 days past the substantial completion date.
- B. Well # 7 Well has been completed, it has tested at 325/375/450 GPM. Final test of 375 GPM for 6 hours was done. 10" pipeline between Well # 6 & Well # 7 has been laid up to the near pad and three (3) additional loads of bull rock were placed near the site on Tuesday. Proposed completion will be around Christmas time.
- C. Street Maintenance Still on hold due to the water line project.
